Second Call of the Visiting Scholar Program 2025: Grants starting in the 2nd half-year

With the Visiting Scholar Program, professors who invite international guest researchers to Chemnitz contribute to the scientific performance, enrichment of university teaching and the international visibility of our university. The Visiting Scholar Program is aimed at tandems of **excellent international guest researchers** and professors of Chemnitz University of Technology (TUC) who have been successfully conducting research together. The program supports research stays of international guest researchers in Chemnitz for a period of three to six months.

What are the requirements international guests have to meet for the program?

- prominent position as professor or experienced postdoc at a university or research institute abroad
- proven successful cooperation with the hosting professorship at Chemnitz University of Technology through joint projects or publications
- specific joint research project to be carried out during the stay in Chemnitz which ideally leads to a joint research proposal,
- the visiting scholar's employment relationship with the home institution continues during the research stay in Chemnitz

In the case of funding already granted in the past in the Visiting Scholar Program, an application is possible, but may have a chance-reducing effect on the evaluation of the application in the overall view of the submitted applications.

What does the sponsorship for the visiting scholar include?

- one-time, country-dependent lump sum for travel expenses for arrival and departure to/from Chemnitz
- for full professors, associate professors, reader etc. a monthly expense allowance of 3,000 Euro for up to 6 months
- for assistant professors, lecturers, postdocs etc. a monthly expense allowance of 2,000
 Euro for up to 6 months

Which framework conditions have to be fulfilled?

- Start of stay in the 2nd half-year 2025
- The stay in Chemnitz lasts between 3 and 6 months.
- The visiting scholar continues to work for his/her home institution during his/her stay in Chemnitz.
- Expenses for the realization of the stay, in particular consumables, are to be borne by the hosting professorship.
- The stay can be separated into a maximum of two parts. However, the lump sum for travel expenses will only be reimbursed once.
- Willingness for the Visiting Scholar to participate in teaching, such as through guest lectures.
- Willingness to evaluate the stay by the Visiting Scholar and the host professorship

Please note: Applicants from Russian research institutions cannot be considered in the current call for proposals. An important objective of the Visiting Scholar Program is the promotion of



research cooperation with a view to applying for joint (large-scale) research projects. According to the Rector's Newsletter 13/2022 of 03.03.2022 (Open Letter from the President Regarding the War in Ukraine), institutional research collaborations with Russian institutions are currently on hold.

How does the application process work?

International guest researchers can submit applications to the International Office together with the hosting professorship. The International Office submits all complete applications received on time to the University Management.

Which documents are to be submitted?

- Jointly completed <u>application for the Visiting Scholar Program</u> with (electronic/digitised) signatures of the Visiting Scholar and the host professorship of the TUC.
- Project description* by the Visiting Scholar and the host professorship (max. 2 pages)
- CV incl. usual information (list of publications/teaching experience)
- PhD certificate
- Confirmation of the home institution regarding the continuation of the employment relationship during the stay in Chemnitz

*The project description contains a brief description of the proposed research project and describes the previous intensity of the cooperation between the Visiting Scholar and the host professorship. In addition, the tasks of the Visiting Scholar at TUC are described, and the goals and expected benefits of the research stay for the professorship and TUC are explained.

When is the application deadline?

Applications can be submitted until 31st March 2025.

Funding conditions in the Visiting Scholar Program

Monthly allowance

Visiting scholars receive a monthly allowance to cover the additional costs incurred during their stay abroad. The allowance is intended to cover costs in Chemnitz such as rent, local transport, meals and health insurance, etc.

Absences from Chemnitz during the Visiting Scholar Program

The goal of the Visiting Scholar Program is that the international guests and host professorships conduct research together in Chemnitz. Participation in conferences or workshops of usual length outside of Chemnitz is of course possible for visiting scholars.

Absences of more than two weeks per funding month must be reported to the IUZ. For these absences only a reduced expense allowance will be paid.

Travel expenses

Visiting scholars receive a one-time travel allowance depending on the country in which they start their journey to Chemnitz. The travel allowance is intended to cover the costs of flight, train or bus tickets for the journey to and from Chemnitz and – if applicable – costs occurred by applying for visa. The travel allowance is paid as a lump sum at the beginning of the stay in Chemnitz. There is no requirement to provide proof of individual expenses for the trip.

Tax and social security liability

Please be sure to note that the payment of the living allowance (Aufwandsentschädigung) on the part of Chemnitz University of Technology is made without deduction of taxes, as the deduction of taxes depends on the personal circumstances of the Visiting Scholar. However, Chemnitz University of Technology is obliged to inform the competent tax authorities about the total amount of annual payments exceeding the limit of 3,000 EUR (Notification Ordinance of September 7, 1993, BGBI. I p. 1154 as amended). This is the case for grants in the Visiting Scholar Program. Subsequently, the tax authorities will ask the grantees to submit a German personal income tax return, for which we recommend consulting with tax experts with knowledge of international tax law.
