



Online Learning Agreement (OLA) Erasmus+ Guidance and instructions

(as of 04/2022)

- ⇒ Please make sure to complete your entire Online Learning Agreement. <u>www.learning-agreement.eu</u>
- ⇒ Please enter the courses to be attended at the host university in Table A in close consultation with the Erasmus subject coordinator of your department and the chair of the examination board (at least 20 ECTS) and in Table B the names of the module achievements/modules according to your study regulations here for the **full** recognition of the courses. Any ECTS credits/achievement points from Table A that are not included in the recognition are added up as an additional entry "Additional qualification" in Table B.

 IMPORTANT: There does not need to be a 1:1 recognition and allocation between the two tables (see example on page 2 of this leaflet). The aim is the **full** recognition of comparable learning outcomes. If your examination board denies you recognition, please contact the International Office (IUZ)!
- ⇒ Please enter your language of instruction at the host university and your existing language level at the latest at the start of your stay under *Language Competence*.
- ⇒ Please sign the Learning Agreement yourself, obtain the signature of your subject coordinator and the examination board chairperson (*responsible person/sending institution*) and send the Learning Agreement scanned by e-mail to the host university for signature and return.

IMPORTANT: The Online Learning Agreement must be completed in full and signed by all responsible persons (student, 'responsible person' TUC, 'responsible person' host university) and sent as a PDF file to Mr. Sachs at the International Office (IUZ) via email at least 4 weeks before the start of your stay.

If changes to the original study plan become necessary at a later date, you can agree these with your examination board up to 4 weeks after the start of the semester and document them with the second part of the OLA "Changes" (signed and sent by e-mail to: oliver.sachs@iuz.tu-chemnitz.de).
